- The Salon Professional Academy has been authorized to disburse HEERF III Funds (Higher Education Emergency Relief Fund III funds) by the most recent American Rescue (ARP) Act 2021, to students for any component in the students Cost of Attendance. This includes room, board, transportation and personal expenses or expenses due to COVID. In addition, the funds may be used for tuition and fees but only with the written consent of the student.
- Similar to the HEERF II, students do not have to be Title IV eligible to receive HEERF III. Student eligibility requirements under Section 484 in Title IV of the HEA of 1965 do not apply when awarding HEERF III. Additionally, HEERF III is also available to undocumented students, Deferred Action for Childhood Arrivals (DACA) students, dreamers and students studying abroad.
- The total amount of HEERF III Funds that The Academy has received from the Department pursuant to the institution's Certification and Agreement for Emergency Financial Aid Grants to Students is \$27,070.00
- The first guarter disbursement allows for 50% of funds (\$13,535.00) available to students who were currently enrolled and attending as of 9/1/2021 and certify the need.
